Discussion of costs to local authorities aired; Borough Councillor Iliffe reported the costs appeared inaccurate. Cllr Watson requested confirmation of policy for County Council reference fly tipping. Costs for installation of CCTV systems discussed and opportunities for funding; availability of scheme to monitor cctv system through Heanor Gate Industrial Estate forum reported by Cllr Watson.

The Chairman reminded the meeting of the forthcoming national Parish & Town Council Elections in May 2023. A request for invitation of the Police & Crime Commissioner to a future meeting noted.

Agreed to refer to the next meeting for full discussion, costs and sources of funding.

The Chairman, on behalf of the Parish Council, extended appreciation to organisers and participants in the Remembrance Service held on Saturday 12<sup>th</sup> November 2022, including attendance of bugler, road closures (Cllrs Kearton & Watson) and Shipley W.I. for providing refreshments. Many favourable comments were received from attendees and residents.

# 66/2023 TO RECEIVE REPORTS

a) Allotments Cllr Watson reported Borough Council had approved works to be undertaken to the fencing/hedge improvement; legal licence awaited. Cllr Watson agreed to pursue the matter and forward copy to the Parish Council on receipt. Contractor had completed hedging maintenance works. It was reported notification regarding trees surrounding the allotment site had been received from County Council September 2022. No further information to date.

**Shipley Parish Rooms Trust** SPRT. Representatives reported on recent meeting of the Trust held. Hiring of facilities good. A new caretaker had been appointed. Lone working processes underway. Quotations for decoration of the premises interior and exterior underway; funding sources for potential repairs/replacement air source heat pump noted.

SEAG. Cllr G. Kearton reported on the group activities and events including funding received from County Council to improve site entrance. Extra drainage had been installed. Lots of new volunteers, events noted including yoga, massage, working with DWT – how to plant seeds using native trees intended to plant in AV. Small nursery established on site, Astronomy evening. Approach from Michael House School artist to join in. Water pumps in and solar panels for lighting discussed. Funding raised and applied for and these will be the main project. Hedges to site maintained; honey for sale produced on site from bee colony.

**Pit Lane Recreation Ground** Pit Lane. The Chairman reported planning approval granted for containers to allow appointed football team to use the ground for games with changing facilities. Local sponsor of the team noted report on potential for youth team games. Lease submitted. Pitch to be re-aligned by team.

**Parish Warden Report** updates submitted; defibrillator checks completed; Pit Lane playground checks completed. Agreement noticeboards to be tidied.
